District 9 Meeting Minutes Feb. 10, 2011

The meeting was called to order at 7:04pm.

Minutes: The District meeting minutes from the last meeting were approved as mailed or emailed.

Treasurer's Report:

The emergency fund is \$9,204.54
The general fund is \$54,281.31 with \$6,075.74 in the umpire fund.
The treasurer's report was approved.

Old Business:

-The DA commented that the leagues are making good progress on the items due district, but there are still some things to be completed.
-Many leagues still have not gotten their ASAP plans submitted and approved. The DA reminded everyone that they should all be completed by March 1, and that there should be no tryouts or practices until all coaches have a printed copy of their approved ASAP plans.

New Business:

-The DA inquired about any sign-up problems the leagues are having.
-Some presidents are experiencing dramatic increases in field use charges. The DA suggested that it might be effective to gather groups of citizens to appeal to their city counsels for explanations.

Training: The DA went over how to fill out accident insurance forms, and where to access them on the Little League website.

Umpires: Chad Christensen reported that they have gotten an overwhelming response to the Umpire Outreach Clinic. However, 25 people who have signed up, have not paid. People who do not pay soon, risk being dropped in favor of those on the waiting list.

-There will be a UIC's meeting on Feb. 23, for both baseball and softball, at the LWSD Resource Center. All leagues are encouraged to send representatives.

-Umpire training will start on March 9. Individual sessions and dates are available on the District 9 website.
